DESCRIPTION

BULLDOG Liquid Binder is a quick drying heavy-bodied liquid compound composed of special asphalts, solvents and a surface active ingredient. Depending upon rate of application it will dry to touch in 3-4 hours and will cure in 24 hours.

USES

BULLDOG Liquid Binder might be used to seal pinhole leaks on gravel roofs without removing the gravel by pouring liquid binder over the surface. However, it is always best to try to remove gravel before undertaking any roof repairs. BULLDOG Liquid Binder might also be used to resaturate asphaltic surfaces that lie beneath mechanical equipment that may be installed on roof in a way that makes it difficult to reach the roof surface.

METHODS AND RATE OF APPLICATION

Apply BULLDOG Liquid Binder by brush, spray or squeegee or by pouring on the surface at rate of 100 square feet per gallon or heavier if necessary. If material is to be poured on surface it can be done easily by opening spout in cover. Exercise caution in any pouring. COVER AIR INTAKES BEFORE APPLYING AND WHILE CURING. EMPTY CONTENTS BEFORE DISPOSING OF PAIL.
