### **DESCRIPTION**

A fibered coal tar coating enhanced by penetrants that help it rejuvenate badly deteriorating coal tar roofs. Part of this compound soaks into dried out roofing felts and part of it remains on the surface to provide water/weather proof protection. SPECIFICATIONS: Federal Specification \*SS-C-540-B \*Exception Non-Asbestos

### **USES**

Use when coal tar felts have dried as a result of unprotected exposure to sun's destructive rays. Sometimes used to restore roof, rather than remove it. This material has a strong odor.

Do not use on asphalt surfaces.

For exterior use only.

### **METHODS AND RATE OF APPLICATION**

Apply with roof brush or spray equipment to dry, sound, clean surface. Remove loose gravel. Depending on condition of surface apply at rate of 7 to 8 gallons per 100 square feet (2.8 to 3.2 liters per M2). If removing existing gravel is desired do so with power brush or other suitable means that will not damage underlying felts. If gravel is to be reused power wash before reusing to remove silt. Reapply gravel immediately after applying Resaturant. Be certain roof can support additional weight. COVER AIR INTAKES BEFORE APPLYING AND WHILE CURING.
